## ORDINANCE NO. <u>2664-06</u>

AN ORDINANCE OF THE CITY OF WINTER PARK, FLORIDA. AMENDING CHAPTER 58 "LAND DEVELOPMENT CODE" ARTICLE III, "ZONING REGULATIONS" SO AS TO AMEND THE SETBACKS FOR LOTS OF 60 TO 65 FEET IN WIDTH TO PROVIDE CONSISTENCY FOR FIRST AND SECOND FLOOR RESIDENTIAL SETBACKS WITH THE SINGLE FAMILY AND PURD ZONING DISTRICTS.

## NOW THEREFORE, BE IT ENACTED BY THE PEOPLE OF THE CITY OF WINTER PARK:

SECTION 1. That Chapter 58 "Land Development Code", Article III "Zoning" of the Code of Ordinances is hereby amended and modified by amending Sections 58-65 & 66. "R-1AAA lakefront district" & "R-1AA and R-1A districts", to amend (f)(8)d read as follows:

## Section 58-65 & 66. "R-1AAA lakefront district" & "R-1AA and R-1A districts"

- f) Site and building improvement regulations.
- (8) Special setback situations.
  - d. In order to allow an additional five (5) percent increase in the allowable floor area ratio as described in subsection (f)(1) "floor area ratio", the following standards addressing second floor setbacks must be met:
