RESOLUTION NO. 1903-05

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF WINTER PARK, FLORIDA, PURSUANT TO SECTION 170.03, FLORIDA STATUTES, CALLING FOR A PUBLIC HEARING TO DISCUSS ALL ASPECTS OF THE INSTALLATION OF AND FUNDING OF PUBLIC IMPROVEMENTS AND MUNICIPAL SERVICES CONSISTING OF STREET BRICK ON A PORTION OF HIBISCUS AVENUE; WHICH IMPROVEMENTS AND MUNICIPAL SERVICES WILL BE PAID FOR BY SPECIAL ASSESSMENTS LEVIED AGAINST ALL PROPERTIES ABUTTING HIBISCUS AVENUE, FROM AND INCLUDING ADDRESS 1600 TO AND INCLUDING ADDRESS 1698, TO LAKEMONT AVENUE; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Commission of the City of Winter Park, Florida, in Resolution No. 1902-05, has determined, and does hereby determine, to make and fund certain public improvements and municipal services as authorized by Sections 170.01 and 170.201, Florida Statutes, by the installation of street bricking along a portion of Hibiscus Avenue, being those properties including address 1600 to and including address 1698, to Lakemont Avenue; and

WHEREAS, the City Commission has determined, and does hereby determine, to make and fund certain public improvements and municipal services as authorized by Sections 170.01 and 170.201, Florida Statutes, by the installation of street brick on a portion of Hibiscus Avenue, being those properties including address 1600 to and including address 1698, to Lakemont Avenue, all of the aforesaid public improvements and municipal services to be hereinafter referred to as the "Project"; and

WHEREAS, the cost and expense of the Project is to be defrayed by special assessments; and

WHEREAS, Sections 170.07 and 170.08, Florida Statutes, require that a public hearing be conducted with respect to the special assessment roll, which has heretofore been filed with the City Clerk of the City of Winter Park, which assessment roll shows the lots and lands assessed and the amount of the benefit to and the assessment against each lot or parcel of land, and, if

said assessment is to be paid in installments, the number of annual installments in which the assessment is divided.

NOW, THEREFORE, be it resolved by the City Commission of the City of Winter Park, Florida as follows:

- Section 1. The City Commission of the City of Winter Park hereby calls a public hearing at 3:30 o'clock p.m. on July 11, 2005 or as soon as possible thereafter, in City Commission Chambers, City Hall, 401 Park Avenue South, Winter Park, Florida for the purpose of affording owners of the property to be assessed, or any other persons interested therein, to appear and be heard as to the propriety and advisability of making and funding such improvements and municipal services, as to the cost thereof, as to the manner of payment therefor, and as to the amount thereof to be assessed against each property so benefitted.
- Section 2. The area to be improved and benefitted are those properties on Hibiscus Avenue from and including address 1600 to and including address 1698, to Lakemont Avenue, by the installation of and funding of street brick on a portion of Hibiscus Avenue. The description of each property to be assessed and the amount to be assessed to each piece or parcel of property may be ascertained at the office of the City Clerk.
- **Section 3.** The public improvement and municipal services proposed shall consist of the installation of street bricking of a portion of Hibiscus Avenue, generally described as those properties from and including address 1600 to and including address 1698, to Lakemont Avenue.
- **Section 4.** The aforesaid public hearing shall be conducted as provided, and for the purposes recited in Sections 170.07 and 170.08, Florida Statutes.
- **Section 5.** This notice shall be published as provided in Section 170.07, Florida Statutes.
- **Section 6.** Twenty (20) days' notice in writing of the time and place of the aforesaid public hearing shall be given to the property owners of the property to be assessed, which notice shall include the amount of the assessment. The notice shall be served by mailing a copy to each of such property owners at his last known address, the names and addresses of such property owners to be obtained from the records of the property appraiser

or from such other sources as the city clerk or city engineer deems reliable, proof of such mailing to be made by the affidavit of the city clerk, deputy clerk, or by the city engineer, said proof to be filed with the city clerk, provided, that failure to mail said notice or notices shall not invalidate any of the proceedings hereunder.

Section 7. This Resolution shall become effective immediately upon its passage and adoption.
