

Shoreline Vegetation Management Services



PROVIDER LISTING PROGRAM

The City of Winter Park will list the names and contact information of companies that provide shoreline vegetation management services, provided that the companies meet the minimum criteria described below, and sign a compliance agreement stating that they have read, understand and agree to comply with all city ordinances related to each category in which they are requesting to be listed. The list of companies that complete this process will be posted on the city's website under www.cityofwinterpark.org/lakes as well as hard copy, available upon request.

Minimum criteria for listing shoreline vegetation management services:

- Must provide documentation that the company is legally registered to do business in the State of Florida.
- Must obtain and read Section 114-6 (shoreline protection code) of the City of Winter Park Code of Ordinances.
- Must sign a compliance agreement stating that the company will comply with all provisions of Section 114-6, and that all employees that will be performing shoreline vegetation management services have read and agree to follow the provisions of the ordinance.
- If herbicides will be used for shoreline management, the company must provide documentation that each employee that will be applying herbicides is licensed as an aquatic pesticide applicator by the Florida Department of Agricultural and Consumer Services (FDACS), and agree to obtain and use only herbicides with current labels for aquatic use in Florida, and agree to follow all provisions of the label(s) of any herbicide(s) used. The company must also agree to obtain and comply with any State permits required for herbicide use.
- Compliance statement must be signed by the company owner, or an authorized company officer.

Penalty for non-compliance

Failure to comply with the terms and conditions of the compliance agreement will result in delisting of the offending company's name for a period of one year, after which the company, at their own initiative, may re-apply for listing. Additional violations during this 12-month exclusion period will result in a restarting of the penalty calendar (a full 12 months without a violation is required before reinstatement will be considered). Any company with three or more violations of the compliance agreement will be permanently removed from the list.

Important legal notice. The City of Winter Park does not warrant or guarantee any of the services or quality of services that may be provided by a company listed on the City's Shoreline Vegetation Management Provider list. The companies on this list have demonstrated that they meet certain minimum criteria that qualify them for inclusion on the list. However, the City is not responsible for any error or deviation in the reporting of information by the company to the City or in connection with verifying the accuracy of information reported. The City has not conducted any background check on the company or any employee or agent of the company, and the citizens of Winter Park are encouraged to conduct their own independent investigation into the qualifications and background of a company before entering a contract or allowing the company to come to a resident's home or business or to perform any work.
