## **EXAMPLES OF ALTERNATIVE SPECIES TO ESTABLISH A DIVERSE CANOPY\***

\*This is not a complete list, only examples of alternative species, highlighted species listed are suitable street trees

Shade Trees	Medium Trees	Understory Trees
Trees with a mature height of 50 - 70 + feet that cannot be planted under overhead electric utility facilities and must have a minimum of 6' planting strip.	Trees with a mature height at 30-50 feet and can be managed if planted near overhead electric utility facilities and must have a minimum of 4' planting strip.	Trees with a mature height of 15 to 25 feet tall that can be maintained under overhead electric utility facilities and must have a minimum of a 3'planting strip.
