1111 W. Fairbanks Avenue

#### background

The City acquired the bowling alley property located at 1111 W. Fairbanks Avenue in 2016 for \$2.9 million. One million dollars came from the CRA and \$1.9 million from General Fund Reserves. The primary purpose of the acquisition was to provide the right of way needed to expand that section of Fairbanks Avenue with an extended turn lane. At the time the Commissioners were not in agreement on the ultimate use of the remainder of the property and deferred that decision until later.

At the CRA work session on April 10, 2017 the majority of the Board agreed that the City and CRA should sell the property after carving off the amount needed for the right of way. Staff is requesting discussion by the CRA advisory board on this direction.

State Legislative Update

#### background

Staff is presenting information relative to the proposed state legislature changes that have a direct impact on the Winter Park CRA. HB 13 and SB 1770 have been proposed to restrict the useful life, expenditure, and expand reporting requirements for CRA's statewide. Each bill has been through subcommittees and towards a final vote. As they stand the bills state the following:

#### HB13:

- Prohibits the creation of any new CRAs in Florida after October 1
- Strictly limits expenditures and strikes the words "including but not limited to" under s. 163.387(6) which is the statutory authorization for CRA expenditures.
- Requires 80% of the government body (a super majority) for a current CRA to stay in existence, along with a new finding of necessity
- Requires new and various types of information in the annual report by each CRA (some of them may be innocuous, some are not)
- Limits current bond maturity and requires a new finding of necessity

#### SB1770:

- Current CRAs: may continue to operate, but requires 80% of the government body (a super majority) to approve continued existence
- Current CRAs: if the supermajority is not achieved, they term out at expiration or 2037 (i.e. no extensions)
- New CRAs after July 1, 2017: requires 80% of the government body (a super majority) to create one
- Requires all CRAs to terminate by 2037 with no extensions in the meantime if they do not

- approve continued existence
- Strictly limits expenditures strikes the words "including but not limited to" under s. 163.387(6) which is the statutory authorization for CRA expenditures
- Requires all CRA boards comprised of elected officials to appoint two additional members with expertise in certain areas
- Requires new and various types of information in the annual report by each CRA
- Limits bond maturity and requires a new finding of necessity

Denning Drive and New York Avenue updates

#### background

#### **Denning Drive:**

At the February 27 CRA meeting, the Agency approved Phases I, II, and III for Denning Drive bounded at Orange Avenue to the south, Solana to the north, and a portion of Webster to connect to the Lee Road extension.

City staff is now coordinating and preparing for work to begin in summer 2017. The intent is to start construction on the south end of the road at the Denning/Orange Avenue intersection and work northward. This allows for the removal of inefficiencies before dealing with more intense portions of the project north of Fairbanks. The intention is for construction zones to move as capably as possible to limit the area of construction disturbance at any given time.

#### **New York Avenue:**

At the direction of the Agency, staff is working with a vendor to generate plans from the New York Avenue concept. Staff will work with the vendor to include opportunities for streetscape improvements including bulb-outs, additional landscaping and trees, crosswalks, bus shelters, and parking spaces. A 30% design is expected in June.
