#### Meeting called to order

Meeting was called to order at 8:18 am.

#### a) Election of Chair and Vice Chair

Motion made by Drew Madsen, seconded by Murray Wilton, to elect Bill Segal as chair. Motion passes 6-0. Motion made by Michael Dick, seconded by Betsy Gardner-Eckbert to elect Drew Madsen as vice-chair. Motion passes 6-0.

#### b) Introduction of New Members

The board welcomed Ginny Enstad and Michael Dick to the board. New members outlined their backgrounds and provided context to their interest on the board.

#### **Consent Agenda**

#### a) Approval of Minutes

Motion made by Betsy Gardner-Eckbert, seconded by Drew Madsen, to approve the April 13, 2021 minutes. Motion passes 6-0.

#### **Staff Updates**

#### a) Economic Recovery Task Force Final Report & Next Steps

Assistant Division Director, Kyle Dudgeon introduced the item providing background on the successes and contributions of the Economic Recovery Task Force (ERTF), their presentation to the City Commission, and stated a copy of the final report was included in the agenda packet for discussion. He continued by stating there were two topics for this item. The first was to absorb the feedback provided by the Commission on the task force report and second to discuss that feedback for synthesized thoughts on next steps. Staff provided a draft of takeaways from the Commission for consideration. The board commented on defining success and vibrancy through attainable values, success metrics, and to create goals that build off one another and create value. Staff continued by expanding on the second goal of the meeting asking for high-level conversation regarding economic vitality given the task force report and Commission feedback. He stated staff's goal was to absorb and synthesize comments for review at the next meeting. The board commented on a 'north star' or goals necessary to solicit economic success and how to measure them appropriately. They additionally spoke to responding to demand, coinciding with the Winter Park vision, the role of sales and visitation of tourism for city revenues, the quality of the experiential economy within Winter Park, the opportunity for businesses to develop/grow within the community, identifying key stakeholders, and what makes Winter Park special? Staff closed by stating strategically it is important to get to a point where there are new programs to respond to these items.

#### b) Data & Initiatives Review

Assistant Division Director, Kyle Dudgeon, stated monthly information related to Park Avenue economic vibrancy, Winter Park/Orlando MSA vacancy and rental rates are provided for the board's review.

#### **Board Comments**

The board confirmed at that 8:15am on the second Tuesday of the month was still a suitable time to meet.

#### **Public Comment**

Phil Anderson, 1621 Roundelay Lane, thanked the board for their thoughts to promote the business economy within the city. He referenced the Winter Park Vision Statement from 2016, and stated it as springboard language for what Winter Park means. He also commented on the need to blend a long-term approach with short-term immediacy.

There being no further business, the meeting adjourned at 9:15 a.m.
