Introduction

The purpose of this Sidewalk Policy (Policy) is to establish processes and procedures to implement sidewalk construction projects on local roads throughout and within the City of Winter Park (City). This Policy is an element of the City's 2019 Mobility Plan (Plan). The Plan is strategized to improve traffic and transportation by encouraging the usage of alternative methods of travel to motor vehicles such as walking, bicycling, and utilizing transit. In addition, the Plan primarily focused on functionally classified roads and areas where the City believes sidewalks are required for the overall improvement of safety for the residents. However, to accommodate the residents' requests for installation of sidewalks, this Policy will define the procedures, measures, and details to implement the requests as a City sidewalk construction project.

Sidewalk Project Identification

In conjunction to the City's Plan, an extensive inventory of sidewalks was developed. To improve and encourage more pedestrian mobility, sidewalk projects are proposed in areas of functionally classified roads and where the City believes sidewalks are required to improve the safety for the residents.

In addition to the sidewalk projects listed in the Plan, residents' sidewalk implementation requests shall be considered by the City. Once the City receives a notification from a resident of desiring to install sidewalks, sidewalk petition forms will be delivered to all residents impacted by the potential installation. All forms must be returned to be counted – forms that are not returned will be assumed against the sidewalk project. The City will take in petitions forms throughout the year, but City's Department of Public Works (DPW) will start evaluating the petitions in March of each year. Any petition forms not submitted by March will be evaluated the following year.

In order to optimize the desire and consideration of all residential lot owners, the sidewalk project will be only be added if the petition resulted in a consensus of 75% or higher. In addition, there must be available right of way to install sidewalks. If there is insufficient amount of available right of way, then property owners whether in favor for or opposing the construction of sidewalks may have to provide an easement to the City in order to move forward with the sidewalk project.

Sidewalk Project Prioritization

Due to the limited funding and resources, the City will develop a Sidewalk Project Priority List (List). This List will have the tentative start order of sidewalk projects determined from utilizing the Prioritization Assessment listed in Table 1. DPW generated this scoring system after researching and reviewing examples of other localities sidewalk priority assessment.

Table 1 Descriptions

Location:

- Schools: The City considers the safety of students as a primary consideration for building sidewalks.
- Lynx stops: Areas with transit services are likely to have more pedestrian activity.
- SunRail Station: Areas with transit services are likely to have more pedestrian activity.

Existing Conditions:

- Petition by Residents: The City will take into account of the residents' desire for installation of sidewalks. As a baseline, there must be at least 75% consent from all impacted residential lot owners.
- Lacking Sidewalk Connectivity (gaps): The City will determine if the area of proposed sidewalk construction has gaps.

In addition to the criteria listed on the Sidewalk Prioritization Assessment Table, the DPW may consider additional criteria internally to determine the feasibility for reprioritizing or removal of sidewalk projects from the List. These internal criteria include but are not limited to:

- Unforeseen engineering consideration such as costly drainage work required to construct the sidewalk
- Underestimated cost due to unforeseen engineering considerations
- Unforeseen construction site conditions
- Substandard front yard setback from the proposed sidewalk, causing severe impact on adjoining properties.
- Advice and input from Transportation Advisory Board (T.A.B.)
- Advice and input from Winter Park City Commissions.

Once the sidewalk project requests are approved by the City, the DPW will add the projects to the List and reevaluate the priority order – the List is subjected to change depending on any alterations within the criteria mentioned above. In addition, if 100% of the impacted residents desire the sidewalks and are willing to pay 100% of their share, then the sidewalk project will be moved towards the top of the List.

The City reserves the right to install or remove sidewalks on the City's right of way at its own expense associated with the capital improvement projects to provide safe pedestrian movement through or around the City.

Repair of Existing Sidewalk

The City will repair sidewalks at its own expense if one of the following criteria are met:

- 1) Sidewalk is damaged resulting from the growth of City trees.
- 2) Sidewalk standards shall meet Americans with Disabilities requirements.

The property owners will repair sidewalk at their expense in the following situations:

- 1) Sidewalk is damaged or destroyed through building construction activities by the property owner. Sidewalk must be replaced immediately upon completion of construction activities causing the damage or within 3 days after notification by the City, whichever comes first.
- 2) Existing sidewalk has deteriorated or failed as determined by the City Engineer due to actions by or for the property owner.
