Staff Updates

Forestry Update

Editable orchid has been planted in collaboration with Winter Park Garden Club off the Cady Way Trail, and should produce fruit in a few years for the public.

Staff has received a correction version with the strike through of the language that will be removed from the current code from the City Attorney, there was a clarification made to the process in which the public will produce information on complying if they choose to utilize Florida Statue 163.045 on private revenue property. The first work session has been scheduled in late September with the Planning and Zoning board to discuss the code revision.

Board Priorities

Staff is asking for the board members to submit some suggested priorities, to place on the agenda for future meetings.

Tree Barricade Requirement-Review Draft Document

Staff gave an update on the tree barricade requirement draft document and focusing on having lot developers improve their tree barricades. The department's goal is to make the barricades effective in the way they are attended.

Sustainability Action Plan Update

Vanessa Balta of the Sustainability Division presented the board with the tree related portion of the Sustainability Action Plan. The current update includes feedback from the public, staff and surrounding organizations. Staff will work with neighboring cities to identify the best methodology to identity the tree canopy. Sustainability staff is looking for direction form the board for longtime targets, objectives and action items. The vast majority of the tree canopy loss is due to private property. Some options and suggestion are incentives for new property owners in an attempt to keep the canopy as it is, and possible partner with OCPS and provide an information kit. Possibly provide different species of trees to the residents. Research establishing an Energy-Savings Tree Giveaway program, that creates an interactive site to determine your savings.

The Sustainability Action Plan will be submitted to the Commission for approval.
