

**CITY OF WINTER PARK
CANVASSING BOARD
MARCH 10, 2009 and March 12, 2009**

The Canvassing Board for the City of Winter Park met at 4:30 p.m. at the Orange County Supervisor of Elections Office, W. Kaley Street, Orlando, Florida. City Clerk Bonham directed the meeting.

PRESENT: Commissioners Karen Diebel, Beth Dillaha and Margie Bridges; City Attorney Trippe Cheek, and City Clerk Cynthia S. Bonham.

The board first reviewed the Logic and Accuracy Test performed on the absentee voting machine.

Ms. Bonham advised the board that they would be using the Orange County canvassing criteria to make the decisions whether ballots would be accepted or rejected. The board canvassed the 14 absentee ballots that were questionable that were either not signed, the signature did not match or were unusual.

The board remained until all precincts were accounted for. This meeting adjourned at 9:00 p.m.

On March 12, 2009, the Canvassing Board convened at 2:00 to certify the election results and to review and count or reject any provisional ballots that were outstanding from election night. The provisional ballots that were accepted were added to the total count after the meeting adjourned.

Ms. Bonham stated she verified the precinct votes from the tapes provided from each precinct and the numbers match what she provided on the spreadsheet.

Kenneth Bradley was declared the winner for the Mayor's seat.

There was a consensus to certify the election results as stated (the final votes are attached).

After certification, the board conducted the manual audit of one precinct and one race.

The meeting was adjourned at 5:00 p.m.
