

**CITY OF WINTER PARK
CANVASSING BOARD
MARCH 9, 2010 and March 11, 2010**

The Canvassing Board for the City of Winter Park met at 5:00 p.m. at the Orange County Supervisor of Elections Office, W. Kaley Street, Orlando, Florida. City Clerk Bonham directed the meeting.

The Canvassing Board consisted of Commissioners Karen Diebel and Margie Bridges and City Clerk Cynthia S. Bonham. The City Attorney's office was also present.

The board first reviewed the Logic and Accuracy Test results already performed on the absentee voting machine by the Elections Office.

Ms. Bonham advised the board that they would be using the Orange County canvassing criteria to make the decisions whether ballots would be accepted or rejected. The board canvassed the absentee ballots that were questionable for various reasons such as they were not signed, the signature did not match or were unusual.

The board remained until all precincts were accounted for and all results were sent in via modem. This meeting adjourned at 8:30 p.m.

On March 11, 2010, the Canvassing Board convened at 3:00 to certify the election results. There were no provisional ballots outstanding from election night to be counted or any not counted ballots.

Ms. Bonham stated she verified the precinct votes from the tapes provided from each precinct and the numbers match what she provided on the spreadsheet.

Carolyn Cooper and Tom McMacken were declared elected into Seats 3 and 4. All Charter amendments, with the exception of #10 passed.

Motion made by Commissioner Diebel to certify the election results as provided (the final votes are attached); seconded by Commissioner Bridges and carried unanimously with a 3-0 vote.

After certification, the board conducted the manual audit of one precinct and one race.

The meeting was adjourned at 5:00 p.m.
