

CITY OF WINTER PARK
CANVASSING BOARD – RUNOFF ELECTION
APRIL 9, 2019 AND APRIL 11, 2019

The Canvassing Board for the City of Winter Park met at 4:00 p.m. on April 9 at the Orange County Supervisor of Elections Office, 119 W. Kaley Street, Orlando, Florida.

The Canvassing Board consisted of Commissioners Sarah Sprinkel and Greg Seidel and City Clerk Cindy Bonham. This was a runoff election with two candidates on the ballot: Pete Weldon and Todd Weaver.

The Orange County canvassing criteria was used to canvass the Vote By Mail ballots that did not meet the criteria. The Canvassing Board canvassed the Vote by Mail ballots that were questionable and decisions were made as to whether ballots would be accepted or rejected based on the criteria. The business of the Canvassing Board concluded around 5:00; the board remained until the election results came in.

On April 11, 2019 the Canvassing Board (Commissioner Seidel was absent) convened at 2:00 to certify the election results and to conduct the manual audit of Precinct 9502. The manual count concluded that the count matched what the Elections Office provided via modem election night.

Todd Weaver was declared the winner of the election with 52.33% of the vote.

Pete Weldon received 47.67% of the vote.
