Deputy Chief King stated that during the Police Department's Annual Meeting Eddie Santos was reelected as the Police Department's Representative for 2015.


Lt. Pearson's retirement party will be held on January 8<sup>th</sup> at 2:00 p.m., in Mead Gardens, all are invited to attend.
