# IV. Police Department

# a. Applicant Interview

Lieutenant Montgomery introduced the following police officer candidate Chris Belcore who gave a brief background and responded to questions by board members. Motion was made by Mr. Rodriguez and seconded by Ms. Butts to certify the candidate. Motion carried.

#### b. SOP 145-Promotions

Chief Deal introduced Captain Marcum who reviewed the changes made to SOP 145-Promotions with Board Members and answered questions. Motion was made by Mr. Marchman and seconded by Mr. Stutzer to approve the revisions made to SOP 145-Promotions. Motion carried.

### c. SOP 180- Extra Duty Employment

Chief Deal stated that due to the recent events in Broward County he will be placing an officer from the patrol division in each one of public elementary schools. We currently have two (2) officers assigned to Winter Park High School, one officer assigned to the Winter Park High School 9<sup>th</sup> Grade Center, and one officer assigned to both Brookshire and Lakemont Elementary. The additional officer would put one full time police officer in each of the two public elementary schools.

An update was given by Chief Deal regarding the Rollins College incident that occurred on Tuesday, March 5, 2018.
