# 2. Approval of the February 2, 2021 Minutes

Board Members briefly discussed the above SOG's and under the direction of the Chairman, it was decided to move forward with the SOG's that were not in question and then review those needing clarification. A motion was made by Mr. Stutzer and seconded by Ms. Pace to approve the following SOG's as presented: SOG 201-Unit Assignments Emergency Response; SOG 202-Incident Reporting; SOG 208-Emergency Evacuation Procedure Signals; SOG-210-Garden Apartment Firefighting Practices; SOG213-Response to Buildings with Systems; SOG 214-Joint Response; SOG 216-Ground Ladders; SOG 225-Marine Rescue 61; SOG 227-Protective Clothing; SOG 238-

Vehicle Incidents; SOG 239-Two-In, Two-Out and SOG 240-Emergency Radio Traffic-Mayday. Motion carried unanimously with a 7-0 vote.

The following SOG's 203, 204, 207, 212 AND 220 were individually reviewed.

Mr. Rodriguez asked for the following changes in SOG 203.01: remove the phrase **on scene commander** and replace with **on scene officer** and asked that the term **law enforcement** be used throughout the SOG for consistency.

Ms. Daniels asked for clarification as to the use of the phrase **Domestic Terrorism** in the heading also clarification as to the use of the wording **Winter Park**.

Chief Hagedorn stated that the use of *Winter Park* refers to the Emergency Communication Center.

**Domestic Terrorism** was a typo and will be deleted during the revision process.

Motion was made by Mr. Warner and seconded by Ms. Pace to approve SOG 203 with the above revisions. Motion carried unanimously with a 7-0 vote.

SOG 204, 207 and 212 were clarified as to the use of the wording, *Winter Park*. Once again Chief Hagedorn explained that **Winter Park** refers to the Emergency Communication Center. Motion was made by Ms. Pace and seconded by Mr. Stutzer to approve SOG 204-. Motion carried unanimously with a 7-0 vote.

Motion was made by Mr. Rodriguez and seconded by Ms. Pace to approve SOG 207. Motion carried unanimously with a 7-0 vote.

Motion was made by Mr. Rodriguez and seconded by Ms. Daniels to approve SOG 212. Motion carried unanimously with a 7-0 vote.

SOG 220-a brief discussion was held regarding what vehicles in the FD's fleet were equipped with the Traffic Pre-Emption devices. Division Chief Fischer provided an explanation as to the vehicles in the fleet that are equipped with the Traffic Pre-Emption device. Motion was made by Mr. Stutzer and seconded by Ms. Pace to approve SOG 220. Motion carried unanimously with a 7-0 vote.

## 6. New Business

## **A. Request for Hiring Test**

Chief Hagedorn requested permission to hold a hiring test. Motion was made by Mr. Rodriguez and seconded by Ms. Pace for a hiring test to be given. Motion carried unanimously with a 7-0 vote.

Chief Deal stated that the Police Department currently has four vacancies and will have five when Lt. Bologna retires in March.

A Civil Service Test will be held on March 5, 2021; thirty-three applicants are scheduled to take the test.

Officer Mariano Roman started on February 22, 2021 and is in Phase I of Field Training.

Two officers are currently in their last phase of field training and three officers have been released to solo patrol.
