Lakes Manager Report

Mr. Egan reported meeting with representatives from Mead Botanical Garden and other interested parties to develop a skunk vine control spraying schedule.

- Mr. Egan distributed water clarity reports and is available for questions by phone or email.
- Maintenance Dredging Lk Killarney canal dredging was completed in September
- Plant Management Hydrilla coverage remains low, but the increasing frequency on Lk Baldwin may warrant a grass carp restocking soon. Staff will be using the airboat rake on Lk Killarney later this week to remove eel grass mats.
- Miscellaneous Ms. Giannotti and two certified aquatics applicators attended the FAPMS conference in Orlando.
- The purchase for replacement of the floating excavator goes to the commission on October 26th.
- A secchi disk summary was provided.

Lakes Patrol - WP Police

Sgt. Locke reported that routine lakes patrols ended for the year, but police are available to respond to lake emergencies. Patrols will start up again in the spring.

Sustainability Report – Abby Gulden

Ms. Gulden announced that she is working with a class from Rollins College Crummer Graduate School of Business. They are conducting a survey of City of Winter Park residents, staff and Advisory Board members.

She also reported on the Lk Killarney Watershed clean up. The cleanup covered the entire Lk Killarney Watershed except for 2 sections, utilized 30 volunteers who collected over 500 lbs. of trash in 2 hours. Local businesses donated items for raffle and provided paddle board and canoe experiences.
