Regular Meeting Recap | June 22, 2020

Mayor's Report

Vice Mayor Carolyn Cooper led the meeting in Mayor Steve Leary's absence.

City Manager's Report

City Manager Randy Knight confirmed the Commission meetings will be moving from Mondays to Wednesdays and in-person (no longer virtual) starting Wednesday, July 8.

The following topics were considered for possible City Commission work sessions:

- Orange Avenue Overlay (to be scheduled for Thursday, June 25, at 1 p.m.)
- Fiscal Year 2020-21 Budget (approved to be scheduled Wednesday, July 8 and July 22)
- Bennet Drive and Executive Drive realignment (no work session scheduled at this time; staff to provide information to the Commission for review)
- Killarney neighborhood annexation (no work session scheduled at this time; staff to provide information to the Commission for review)
- Hotel on Pennsylvania and Henderson Hotel (individual applicants can follow the public process; no work session scheduled at this time)

Consent Agenda

- All items were approved.

Action Items Requiring Discussion

East Central Florida Regional Resilience Collaborative Memorandum of Understanding (MOU)

- The City Commission approved the signing of the MOU.

Board Appointments

- In accordance with the newly adopted board appointment process, each Commissioner and the Mayor made their city advisory board appointments and all [appointments](#) were acknowledged. The Commission also approved the appointments to the Winter Park Police Officers Pension Board, Winter Park Firefighters Pension Board and Commissioner Sheila DeCiccio was appointed to the Winter Park Library Board of Trustees.
- For these initial board appointments, those that will serve one year will be considered a partial term and those who will serve two years will considered a full term.

Citizen Comments

- Citizen comments were shared regarding systemic racism, face mask coverings and the ability for the public to continue participating virtually during City Commission meetings when in-person meetings resume.

Public Hearings

Extending the westbound left turn lane on Fairbanks Avenue

- The second readings of two ordinances related to the city's request to extend the westbound left turn lane of Fairbanks Avenue onto Orlando Avenue (U.S. Highway 17-92) were approved.

Micromobility Ordinance

- The first reading of an ordinance outlining the prohibitions related to micromobility devices and motorized scooters was discussed. This ordinance passed on first reading with amendments. This ordinance will go to the [Transportation Advisory Board](#) before returning to the Commission for second reading.

Resolution for changing City Commission meeting day

- [Resolution 2232-20](#) was approved to move the regular City Commission meeting days from the 2nd and 4th Mondays to the 2nd and 4th Wednesdays. The meeting time remains at 3:30 p.m.
