City Manager's Report

A City Commission work session will be scheduled to discuss 5G.

Consent Agenda

All items were approved.

Action Items Requiring Discussion

- The City Manager's evaluation was discussed and a bonus was approved.
- The City Commission approved to give fuel cost recovery over the course of 2021.
- Alternative #2: Existing Bennett Avenue Alignment Remains, was approved for the roadway alignment of Bennett Road and Executive Drive in connection with the Ravaudage development.
- Staff was approved to move forward with the first reading of the micromobility ordinance at the next City Commission meeting.
- Staff presented a list of capital projects to be considered for a bond referendum. Five items were approved for consideration to move forward with a draft ordinance. A strategic planning session is to be scheduled in early December to discuss further.

Public Hearings

- The resolution adopting Municipal Facilities Single Use Plastics Policy was approved.
- The resolution approving and authorizing the execution of the License Agreement with Florida Department of Transportation concerning sharing real time traffic system data and the joint use of the regional-integrated corridor management (R-ICM) software system was approved.
- The second reading of the request of the City of Winter Park for an ordinance to amend Article IV "Sign Regulations" providing for revised regulations relating to temporary signage was approved.
- The second reading of request of the City of Winter Park for an ordinance amending Article IV
 "Sign Regulations" providing for revised regulations relating to definitions; modifications for
 signage in certain zoning locations; and clarifying the types of permitted and prohibited signs was
 approved.
- The first reading of the ordinance proposing amendments to the charter related to establishment
 of single member districts and providing for referendum at the election on March 9, 2021, was not
 approved.
- The first reading of the ordinance amending adopted FY20 Budget was approved.

- The requests of Z Enterprises and resolution related to 1530 Wilbar Circle were approved.
- The first reading of the ordinance related to the request of Jim Veigle for the annexation of 2269/2267/2265/2263/2261/2259/2257 Kentucky Avenue was approved.
- The first readings of the ordinances and Conditional Use approval related to 1800 Karolina Avenue were approved.
- The request of Benjamin Partners, Ltd. regarding a resolution adopting amendments to the Second Amendment to the Amended and Restated Development Order for the Ravaudage Planned Development was approved.
