 - The second reading of the ordinance establishing Commercial Future Land Use, was approved.
 - The second reading of the ordinance establishing Commercial (C-3) Zoning on the annexed property, was approved.
- The following actions were taken regarding the [requests of the City of Winter Park](#):
 - The second reading of the ordinance establishing single-family Future Land Use on the annexed properties at 443 East Kings Way, 1808, 1811, 1815, 1819, 1906, 1907, 1910, 1914, 1915, 1918, 1919, and 1923 Stonehurst Road and to indicate the annexation on the other maps within the Comprehensive Plan, was approved.
