AN ORDINANCE OF THE CITY OF WINTER PARK, FLORIDA, AMENDING WITHIN THE CHARTER LAWS OF THE CITY OF WINTER PARK, SECTION 1.02 "CORPORATE LIMITS DESCRIBED" SO AS TO ANNEX THE AREA HOLDING THE SINGLE FAMILY HOMES ON TEMPLE TRAIL AND COVE TRAIL NORTH OF HOWELL BRANCH CREEK, MORE PARTICULARLY DESCRIBED HEREIN; PROVIDING FOR A REFERENDUM APPROVAL BY THE REGISTERED ELECTORS OF THE CITY OF WINTER PARK AND OF THE AREA PROPOSED TO BE ANNEXED; PROVIDING AN EFFECTIVE DATE.

BE IT ENACTED BY THE PEOPLE OF THE CITY OF WINTER PARK:

Section 1.02 "Corporate Limits That SECTION 1. Described" of the Charter Laws of the City of Winter Park be hereby amended and modified so as to annex the area generally including the properties on Temple Trail and Cove Trail north of Howell Branch Creek, more particularly described in Exhibit "A" (attached) and depicted in the map of Exhibit "B" (attached).

SECTION 2. This ordinance proposing to annex the property herein described to be included within the corporate limits of the City of Winter Park shall be submitted to a separate vote of the registered electors of the City of Winter Park and of the area herein proposed to be annexed. The referendum for annexation shall be held on Tuesday, November 3, 1992. Such election shall be held in conformity with the laws and ordinances now in force relating to elections in the City of Winter Park and Orange County, and in conformance with the provisions of Chapter 171, Florida Statutes.

SECTION 3. This ordinance shall take effect immediately on its passage and adoption, and the annexation shall take effect on September 1, 1993 providing an affirmative vote in the referendum for annexation of the property described in this ordinance by both the registered electors of the City of Winter Park and the area proposed to be annexed, described herein.


