

## information sheet

On November 1, 2017, Adjaye Associates presented the conceptual designs for the new library & events center to the City Commission and an audience of over 300 attendees. Based upon those conceptual plans, the information below was developed. As the plans move toward more detailed design, and additional input is provided by the City Commission and users, this information may be modified and is subject to change.

## **Code requirements**

As proposed, the project will meet city codes for:

- Height
- Setback
- Parking
- Floor Area Ratio
- Storm Water Management

## **Campus approval**

In May 2018, the City Commission approved the "Winter Park Canopy" as the name of the campus that will house the new library & events center. The Canopy will be an approximately 50,000-square-foot campus.



## **Parking**

#### spaces

Proposed >> 237 parking spaces on site Code requirement >> 146 spaces

Existing library parking » 90 spaces [70 onsite+20 in partnership with The Alfond Inn] Existing civic center » 115 spaces Total » 205 spaces

Special needs & short-term parking »
Included in the proposed 237 parking spaces, there will be limited parking close to the front entry intended for special needs and short-term parking. The parking is intended to be broken up by tree islands and landscaping to minimize the impact to the park along Morse Boulevard

#### type of parking

Proposed » surface parking only [subject to change as plans advance]

#### overflow parking

opportunities exist at neighboring properties

## **Budget**

Bond referendum » not to exceed \$30 million bond

City Commission » approved \$27.5 million with option to issue another \$2.5 million as approved by the voters

Winter Park Public Library » to raise \$2.5 million

Total budget >> \$30 million
