## **Reminder: fertilize correctly**

Fertilizers must be used properly and carefully to avoid pollution of our waterways and groundwater – everything is connected. As a reminder, from October 1 to May 31, fertilizer containing nitrogen is permitted, however, it must contain at least 65% slow-release nitrogen. The fertilizer blackout period is June 1 through September 30 of each year. During this period, no fertilizer containing nitrogen or phosphorus may be applied.

helpful tips to keep your yard beautiful & our lakes clean

- Always follow the label directions when using any pesticide.
- Do not deposit fertilizer or grass clippings on streets, driveways or in storm drains.
- When using a broadcast spreader, it must have spray/deflector shields to keep fertilizers off of paved surfaces.
- Clean up any spills immediately.
- Always dispose of unwanted pesticides at an approved household hazardous waste facility.

- Keep fertilizer at least 25 feet from natural bodies of water.
- Limit each application to 1 pound total nitrogen per 1,000 square feet.
- Check weather forecasts before applying any outdoor pesticides, and refrain from using them if windy conditions exist, or if rain is expected within 24 to 48 hours.
- Choose phosphorus-free fertilizer. Florida soils hold phosphorus very well, and rarely need any to be added.

## **PET OWNERS: PLEASE READ**

It is easy to think everyone loves our pets as much as we do, but if your pet is a dog and it is running off leash in undesignated areas or you allow them to defecate on someone's property, both are against city ordinances and very unfavorable to neighbors.

#### please be kind & pick up what's left behind

As much as we love our pets, no one loves to accidentally step on or see the mess they have left behind. Not picking up after your pet is not only unsanitary, it is also in violation of city code [Chapter 18, Section 18-44]. As responsible pet owners, please be cognizant of picking up after your four-legged friends.

#### leash or no leash?

When in public, dogs must be on leash at all times, unless you are visiting the off-leash area at Lake Baldwin Park (located at 2000 S. Lakemont Ave.) or have approval for events where dogs are engaging in competitions, training, or performances which require dogs to be off leash [Chapter 18, Section 18-14]. All other areas that allow dogs require them to be on leash and under the handler's control.

#### it's hot out there

Be sure to keep plenty of fresh water available for pets at all times and make sure your animals have access to shade from the sun. The summer weather is synonymous with thunderstorms, so be sure to bring your pet inside or provide a safe, sturdy shelter for them to be protected during storms.

#### please be respectful

As the weather warms up, more people are enjoying the outdoors. Nothing ruins this more than stepping in a pile of dog excrement or having a strange dog jump on or chase you. Please be respectful those around you by keeping your pet leashed and picking up after them when they answer the call of nature.
