## City Manager's Report

## Future of the former library building

In June, the city is scheduled to receive proposals from interested parties sharing their public-private vision for the former library property located on 1.75 acres at 460 E. New England Ave. Acknowledging this property is within close proximity to residential and also its limited parking options, the Request for Proposals (RFP) is seeking visions to "create vibrancy and promote creative reuse of this municipally-owned property" working within the RFPs parameters.

Because the city decided to not sell or demolish the approximately 33,000 square foot building, the RFP is asking for a market rate lease offer and encourages transformation of the internal space into "a place of excitement and community gathering space in the heart of downtown Winter Park." Specifically, the City Commission is interested in hearing proposals that make use of new trends that can repurpose older civic buildings and create unique activity centers for all to enjoy. Ideas of turning the facility into an active and diverse collection of tenant uses that inspire the entrepreneurial spirit and engage gathering spaces, are welcomed. Revenue generating activities could offset arts, cultural and non-profit elements and allow the project to stand on its own financially. Some existing comparisons of interest were the Oxford Exchange and Armature Works in Tampa and Seattle Center Armory in Seattle, WA.

We are excited about what the future holds for the former library building and look forward to reviewing the proposals for consideration. At the time of writing, a date has not been set for City Commission discussion or decision. ## **COMING SOON: New Central Park Main Stage**

If you have walked or driven by Central Park since the end of April, you would have noticed fencing surrounding the old main stage. Inside that fenced area is the active construction of a brand-new Central Park Main Stage, that when finished, will complement the charming architecture of the Winter Park Train Station.

The original main stage was constructed in the 1980s and the only significant improvement made to the stage since then was a refitting of the canopy due to damage endured from the hurricanes of 2004. The city's Community Redevelopment Agency marked this project as a priority and the new stage is scheduled for completion by September 2022, just in time for its inaugural use at the Winter Park Autumn Art Festival.

The stage is perfectly situated within Park Avenue's bustling commercial district and serves as host to over 75 large events throughout the year including family-oriented activities, concerts, movie nights and yoga and fitness classes, to name a few. This stage renovation allows the city to continue to showcase a variety of entertainment that inspires all, for generations to come.

# It's all about community Obstacles in your path?

When going for a walk or run in your neighborhood, it should not be an obstacle course. Here are some items from Chapter 22 Article V that explain the codes related to property and building maintenance:

#### weeds, shrubbery & overgrowth

- Trash, rubbish or noxious matter (accumulation of sand, leaves, algae growth, slippery
  conditions, food or food residue, and vegetation) must be cleared and cannot remain on a lot,
  place, area, sidewalk or street right of way.
- Weeds, undergrowth, grass, shrubbery or hedges cannot be left to grow over or on any sidewalk and cannot obstruct or interfere with the safe passage of pedestrian traffic on the full width of any sidewalk.
- Weeds or grass cannot be left to grow to a height exceeding 12 inches upon any portion of their lot or upon any sidewalk, over street curbs or street right of way abutting such lot, place or area.
- Shrubs, hedges, trees or plantings shall be kept trimmed so that the visibility for motor vehicle drivers is not obstructed at street intersections and points of ingress and egress to the public right of way.

## sanitation & storage of materials

 Any old, broken lumber, rusted or unused equipment, discarded refrigerators, stoves, old pipe or other used, discarded and worn, unsightly articles or materials cannot remain in any yard or open area owned, occupied or in the possession of such person for a period of more than five days.

Failure to comply with city codes could result in fines or liens upon the property.

#### **Business façade renovation programs**

The Community Redevelopment Agency (CRA) & Economic Development Division offers two types of business façade improvement programs. Both programs are on a first-come, first-served basis.

#### **CRA Business Façade Program**

- offers a 50% matching grant up to \$20,000 to be used toward exterior improvements to businesses within the CRA District.
- supports economic stability, maintains character & quality of commercial districts through leveraging private-public funds.

#### **Citywide Façade Matching Grant Program**

- offers a 50% matching grant up to \$20,000 for eligible improvements [storefronts, paint, signs & awnings | water & sewer connections and parking lot landscaping might also be eligible]
- provides financial incentive to encourage exterior renovation & reinvestment in the city's commercial corridor properties.

## Lakes news & info

## Keeping our lakes clean

#### helpful hints

- Always follow the label directions when using any pesticide.
- Never use pesticides within 30 feet of a lake, ditch or stream.
- Check weather forecasts before applying any outdoor pesticides; refrain from using if windy conditions exist or rain is expected within 24 to 48 hours.
- Clean up spills immediately & always dispose of unwanted pesticides at an approved household hazardous waste facility.

## fertilize responsibly

- Use a phosphorus-free fertilizer with time-released nitrogen & spray shields to keep fertilizers off of paved surfaces.
- Do not apply fertilizers within 15 feet of a lake or any other waterway.
- Do not apply fertilizers containing nitrogen or phosphorous from June 1 through September 30.

#### Public boat ramp closure reminder

The Fort Maitland Park public boat ramp will be closed for approximately four more months, weather permitting. Although the city's Parks & Recreation Department has made efforts to secure alternative overflow parking for Dinky Dock Park, you may still experience a shortage of spaces during peak boating times on Lake Virginia over the summer months.

## **Rise in fuel costs = rise in utility bills**

High energy costs are impacting everything, including utilities. What drivers are experiencing at the gas pumps is also being experienced by customers in their utility bills. The city purchases its power using long-term bulk power contracts with the Florida Municipal Power Association (FMPA) and Orlando Utilities Commission. In addition, it also purchases 10 MW of power from Covanta®, which derives power from burning waste. The city is working with FMPA to keep costs as low as possible.

The cost of fuel is directly passed on to the customer as a specific line item on bills. When agencies see a rise in fuel prices, the city's cost to purchase the power also increases, thus resulting in higher electric bills. A 1,000 kWh residential customer may see an increase in their monthly bills by as much as \$15 per month. This is not unique to Winter Park. All electric utilities are experiencing this same challenge. Because the utility is municipally-owned and the city has local control over other costs, its rates are competitive with other utilities in Florida. As of the latest electric bill comparison data available for Florida electric utilities (March 2022),

Winter Park's charge for a 1,000 kWh residential customer was \$121.15 as compared to an average of \$123.80 for all municipal electric utilities. Other utilities may be more or less responsive to the increasing fuel costs which will have an impact on these comparisons.

Because we live in Florida, the driving factor for energy use is air conditioning. The best way to manage energy use is to maintain the thermostat temperature at 78°F during the warm months and 68°F in mild weather. Additionally, setting the thermostat to a higher temperature while the house is empty – especially during the hot summer months – can help you save up to 17% each month on your bill.

## **Historic designation**

On March 29, the city proudly became one of only 83 government agencies in Florida that is designated as a Certified Local Government (CLG). According to the Florida Division of Historical Resources, the CLG Program was enacted as part of the National Historic Preservation Act Amendments of 1980. It links three levels of government — federal, state and local — into a preservation partnership for the identification, evaluation and protection of historic properties. The city is now a local partner in the Federal Preservation Program and will continue to encourage the addition of more properties to its over 200 historically designated homes and four historic districts. ## **Motorized scooters & golf carts**

For those who enjoy riding on a motorized gas or electric stand-up scooter, you must follow the rules that apply to bicycles and yield to pedestrians. Also remember, if you are under the age of 16, helmets are required.

The only golf cart that is permitted on Winter Park roadways are those that qualify as "street legal" or Low Speed Vehicles (LSV). All LSVs are limited to roadways where the speed limit is 35 mph or less, and required to have a top speed greater than 20 mph, but not more than 25 mph. LSVs must also be registered, insured, and operators must wear a seatbelt and have a valid driver's license.

## **Upgrades for the Community Playground**

Martin Luther King, Jr. Park features a very large playground called the Community Playground, also referred to as Castle Park (the turrets in the structure gives it the castle-like appearance). This playground was built in 1987 and has been a fort, castle and imagination land for thousands of children over the past 35 years. The wear and tear of these happy feet and hands has put the structure in need of renovation and upgrades to be compliant with today's playground safety standards.
