# **Mayor's Message**

### Welcome to the start of summer!

School is out, vacations are planned, and the grill is going. Summer really speaks to enjoying our freedom and community in so many ways. Of course there are the formal celebrations of Juneteenth and our city's Annual Fourth of July Celebration, both coming up soon. Here in Winter Park, we celebrate summer in many other ways. If you have chosen Winter Park to live in or visit, you probably came for the sun, but also for the shade from our tree canopy. You probably chose Winter Park because of its arts and culture organizations (and in the summer because of their air conditioning). And you chose to live here because of the outstanding people that work here and help make our community great. Our commissioners and staff work hard to make sure we have a special place to live, work and play.

To make the most of both our sun and our shade, we recently committed to a comprehensive Sustainability Action Plan. One focus is on our tree canopy. Trees are so important – they keep us cool, drop the temperature about six degrees during the summer, and pump out fresh air. Our Urban Forestry team works hard to preserve trees and also plant new ones. In fact, on Earth Day in April alone, our team gave out 1,400 trees in celebration. We have also prioritized using the sun to generate power. By the end of 2025, the city will have a total of 20 megawatts of solar power to add to our electric utility's capacity. Our electric utility serves around 80% of our residents and has some of the lowest power costs in the area.

We also celebrate summer as a great time to cool off, indoors and outdoors. Winter Park is proud of its thriving museums, arts and culture organizations, library facilities, and of course, shopping. The new "Park Avenue District" has just been recognized as part of the Main Street America<sup>™</sup> program. Outside, take a dip in the city pools at the Winter Park Community Center and Cady Way, or get out on a lake. And of course, we are well on our way with improving our two golf courses, our historic Winter Park Golf Course (WP9) and Winter Park Pines Golf Club (WP18), keeping the family feel but making each one better.

We also celebrate the people that make it all happen. We still have the best police and fire response times in the region. Our parks, lakes and urban forestry teams are outstanding. Our streets teams are working hard to make our roads safer...and for the brick streets...smoother! And our senior management and commissioners are doing the job within a balanced budget.

Years ago, our residents identified the top two character traits that make us special: 1 history & heritage & 2 small-town feel.

These values continue to drive our decisions.

## Becoming a smart city

The City of Winter Park and its consultant, Magellan, will host a community meeting **Thursday**, **June 15, from 5:30 to 7 p.m.**, at the **Winter Park Country Club** located at 761 Old England Ave. The meeting will be structured in an open-house style where attendees can easily stop by and talk with representatives about the new ways the city can become "smarter" through the use of new technologies and data analysis. With the proper infrastructure in place, connectivity of these technological advancements can allow the city to optimize transportation, deliver municipal services, and provide next-generation utilities, all while improving the quality of life for its residents, businesses and guests.

The city is asking for input related to the various types of smart city improvements that are being considered. In addition, the city will explore opportunities to improve high-speed internet access and connectivity to support these smart city initiatives. Whether it is the installation of fiber to homes/businesses, addition of new electronic devices such as digital signage, strategic placement of sensors and cameras, or implementation of digital infrastructure improvements such as incident/outage management technology or 2-way citizen communications, the city is seeking feedback on the following four smart city pillars identified within its vision:

**intelligent transportation** Measures, monitors and controls the flow of traffic through the city by reducing congestion, optimizing routes, detecting accidents, avoiding idling pollution, as well as detecting and communicating available parking.

**utilities** Offers next-generation utility services that are reliable, efficient, secure and sustainable with exceptional customer service.

**public safety** Equips first responders with the tools, technology and training to plan for and respond to emergencies swiftly and effectively, while balancing the public good with individual privacy.

**quality of life** Fosters a welcoming environment that thrives on technical innovation and modern conveniences.

# **Commissioner's Column**

## A message from Commissioner Todd Weaver

Greetings friends and neighbors,

This quarter I am honored to host the Winter Park City Commissioner's Column. I wanted to address a subject that is top of mind for all of us at this time of year: stormwater and how we deal with it.

When we have heavy rains, our lakes are the primary recipients of stormwater, but they are not the only ones. The water comes not just from the rains, but also from runoff from our streets and landscape.

One path for stormwater to drain into the aquifer is our greenspaces – our parks, lawns and gardens. Our non-paved, non-built areas are vitally important to allow rain to naturally absorb into the soil and reach the aquifer. This is why your City Commission is committed to closely following our building codes.

Another way for this water to drain is through a system of strategically placed drain wells. These drain wells are vertically connected directly to the Florida aquifer via pipes that are 6" to 24" in diameter. You might call them "rapid aquifer recharge systems."

Some of the drain wells were built in response to Hurricane Donna in 1960. Donna was similar in many ways to Hurricane Ian. She blew in on a path through central Florida and traveled north, causing widespread flooding of the entire St. Johns River basin from Orlando to Jacksonville.

While neither Donna or Ian set records for rainfall in a day (Tropical Storm Fay in 2008 dumped some 25" of rain on us in a 24-hour period), what was so devastating was that stormwater from both Donna and Ian created a complete blockage to the normal flow of our main drainage outlet, the St. Johns River. This prevented floodwater from escaping from our area into the Atlantic Ocean. As a result, the floodwaters were trapped in central Florida for days, providing plenty of time to cause major damage.

The state no longer allows new drain wells. This means we have to find other ways to safely hold stormwater, divert it, and/or proactively open the drain wells several days before we know a major storm will arrive.

Our city staff is working with the Federal Emergency Management Agency (FEMA), other government agencies, and consulting professionals on engineering upgrades and compiling new best practices for stormwater infrastructure maintenance.

Some of the federal American Rescue Plan Act (ARPA) funds Winter Park received were allocated to dredge the Venetian Canal (which connects Lake Osceola to Lake Maitland), as well as the Fern Canal (which connects Lake Virginia to Lake Osceola). Those canals were impacted with sediment buildup which impedes boat navigation from one lake to another. This buildup also slows stormwater flow to the lower Howell Creek basin. The dredging began in mid-April and is expected to be completed over nine weeks, weather permitting.

We were fortunate to have received a grant from the Natural Resources Conservation Service (NRCS). This funding will support several projects which have been introduced as a result of the storms of 2022. A few of these projects will include dredging of the drainage ditches and ponds throughout the WP18 Golf Course, restoration of the embankments of Howell Creek in Mead Botanical Garden and in the Howell Branch Preserve, dredging of many stormwater outfalls throughout the city, and restoration of the 9th Grade Center retention pond. The first project will be dredging at the WP18 Golf Course.

Thanks to everyone for your patience, especially those of you who had flood damage to your homes. City staff, advisory boards and the City Commission have made our storm preparedness a priority, so that we are ready with a robust response when Mother Nature strikes again. #### It's time to update our Comp Plan

Per the requirements of Chapter 163 of the Florida Statutes, the city is updating its Comprehensive Plan (Comp Plan). This update will reflect any changes that have occurred since the adoption of the 2017 Comp Plan and will not be a complete re-write. Although a majority of the Comp Plan will remain unchanged, the data and analysis sections that direct the policies of the plan will be updated. The Planning & Zoning Board (Local Planning Agency) and City Commission will hold a series of work sessions and public hearings for citizen input, with a goal to complete the updates before the end of 2023. As more specifics are determined, the schedule of these public meetings will be accessible at <u>cityofwinterpark.org/comp-plan</u> as well as via a citywide notice.

# It's all about community Playground update

Over the past year, city staff and members of the Parks & Recreation Advisory Board (PRAB) and Community Redevelopment Advisory Board (CRAB), along with city consultants, Dix Hite, have held several community input meetings related to the renovations of the Community Playground (also known as Castle Park) at Martin Luther King, (MLK) Jr. Park. After decades of wear and tear, the playground is in need of renovations, including improvements to bring the playground into compliance with today's safety standards.

A conceptual design was brought forward at a joint CRAB/PRAB meeting in April. It presented a good balance of preserving key structures and the identity of the current playground while also adding updates and improvements, such as better visibility, water features, accessibility, line of sight adjustments, inclusiveness and modern safety standards. # Lakes news & info Keeping our lakes clean helpful hints

- Always follow the label directions when using any pesticide.
- Never use pesticides within 30 feet of a lake, ditch or stream.
- Check weather forecasts before applying any outdoor pesticides; refrain from using if windy conditions exist or rain is expected within 24 to 48 hours.
- Clean up spills immediately & always dispose of unwanted pesticides at an approved household hazardous waste facility.

#### fertilize responsibly

- Use a phosphorus-free fertilizer with time-released nitrogen & spray shields to keep fertilizers off of paved surfaces.
- Do not apply fertilizers within 15 feet of a lake or any other waterway.
- Do not apply fertilizers containing nitrogen or phosphorous from June 1 through September 30.
