Commissioner's Column

What will it take to keep our "village charm"?

Most of us live here because of Winter Park's lovely urban environment, its quirky shopping district, walking and jogging spaces, parks, festivals and shaded residential areas.

But Winter Park is like an island surrounded by a sea of threats: out-of-control growth, degraded traffic conditions, powerful climate-induced storms, old and often failing regional infrastructure. With deliberate planning, we can manage these threats but make no mistake – it will be costly.

City leaders have constructed 5- and 25-year capital improvement plans to address these threats, but plans are only as good as their execution. Among the capital projects and 25-year costs (millions of dollars) are:

- » Property acquisition for green space & traffic improvements \$35M
- » Transportation infrastructure & pedestrian safety \$145M
- » Stormwater management \$75M
- » Public safety & first responders \$13M

Our annual capital budget of \$2.5 million to \$3 million a year will not cover the cost of these and other critically important improvements. We are going to need an additional \$4 million to \$6 million per year. To do this, we need to raise property taxes.

A millage rate increase of 0.6 mill translates to an additional \$5 million per year. For a \$500,000 home, with a tax of \$2,456, the cost per month would be \$25. If approved by the Commission, it will be the first rate increase in 16 years. Of 12 local municipalities, our millage will still be below average and fifth from the lowest.

As a Winter Park home owner, I consider this \$25 per month an investment in our home and beautiful environment. What is it worth to you?

City Manager's Report

Orange County approves two major city requests

Over the past two years, at the City Commission's request, staff has been performing an in-depth analysis to modify the boundaries of the Community Redevelopment Area (CRA), extend the CRA's operational period 10 years, from 2027 to 2037, and update the Community Redevelopment Plan. I'm happy to report, at the October 29 Board of County Commissioners (BCC) meeting, they unanimously approved the extension and expansion of the CRA. Along with a consultant, GAI/CSG Consultants Inc., staff worked to provide exhaustive community outreach and meet statute requirements.

I'd like to extend a special thank you to Mayor Sheila DeCiccio for attending many one-on-one meetings with Mayor Jerry Demings and each County Commissioner in addition to speaking on the city's behalf at the BCC meetings. We are eager to continue to enhance and grow the city's tax base, while beautifying neighborhoods, and upgrading aging infrastructure.

At the same meeting, the BCC also approved \$8 million in Tourist Development Tax (TDT) funding for the city to acquire, expand and restore the Winter Park Playhouse at its current site located at 711 N. Orange Ave. The acquisition of the property will create a permanent home for the Playhouse, which has a proven record of attracting tourists to the city and county. With support of Orange County's

TDT funding, the expansion of the auditorium (from the current 123 seats to 185 seats) will increase capacity by 50% and enable 10,000+ more residents and guests to attend the popular shows. The Playhouse is the only professional musical theater in central Florida and entertains over 30,000 people annually. They are an important player in the city's arts and culture scene and we value the talent and impact they bring to our community.

Helpful irrigation reminders through March 9, 2025

- Irrigation between 10 a.m. and 4 p.m. is PROHIBITED.
- Water no more than one hour per zone, or 3/4" per zone per day.
- **ODD numbered addresses OR properties with NO addresses** MAY water Saturday between the hours of 4 p.m. and 10 a.m. Sunday
- **EVEN numbered addresses** MAY water on Sunday between the hours of 4 p.m. and 10 a.m. Monday
- Non-residential properties MAY water on Tuesday between the hours of 4 p.m. and 10 a.m. Wednesday
- Properties with new lawns or landscaping are EXEMPT from the restriction for the first 30 DAYS.
- If using private wells or pumps for irrigation, ground or surface water, AND water from public and private utilities MUST comply with the St. Johns River Water Management District's Restriction.

Keep and eye out for a new online art feature

The Public Art Advisory Board (PAAB) and city staff are excited to be launching the city's first-ever comprehensive online Public Art Collection. Accomplishing one of the PAAB's top goalsof 2024, this collection features over 90 pieces of art representing various mediums from artists around the world.

Each piece's "digital didactic" features the artist, photo, medium, creation date and location. All pieces of the collection are in public city facilities or spaces, including the Library & Events Center, Martin Luther King, Jr. Park, Shady Park in Hannibal Square, Welcome Center and City Hall.

The new online catalogue also features an interactive locator map so art enthusiasts can easily locate and visit each piece. You may access the city's new online Public Art Collection at cityofwinterpark.org/public-art.

Attention Electric Vehicle Owners

On November 1, the city began charging to charge at its EV charging stations. Since the City of Winter Park installed its first charging station in 2012, the usage patterns associated with EV charging have changed. The charge-for-free nature of the city's public-facing charging stations has become a source of increasing complaints related to vehicles using a charger for extended periods including overnight, parked un-connected to a charger, or left connected to the charger for extended periods when already fully charged.

To reinforce the true purpose of the spaces created exclusively to charge EVs, the city is now implementing its new EV Charger connection rates:

- \$1 per 20-minutes of connected time billed at the start of the charging period
- add \$10 per hour after 3 hours of connected time billed at the start of each hour

In addition, the Winter Park Police Department will begin issuing citations to enforce the following parking restrictions at public-facing EV charging station spaces:

- EVs must be connected to the charging station when parked in an EV parking space.
- Non-EVs are prohibited from parking in spaces designated for EV charging per city ordinances.

Charging to charge is not unique to Winter Park, in fact charging rates are a normal function of EV ownership. They are applied by utilities such as Orlando Utilities Commission (OUC) and Florida Power and Light at stations located at OUC Robinson Recharge Mobility Hub, along with the cities of Dunedin, Green Acres, Celebration and Jacksonville Beach.

Leaf blower ordinances & education

On January 12, 2022, the City Commission approved Ordinance #3230-22 that outlined the following:

 All internal combustion engine or motor leaf blowers [including landscape company usage] are limited to:

Monday thru Saturday 7 a.m. to 6 p.m. Sunday | noon to 6 p.m.

- Any debris blown into the public right of way must be removed within 30 minutes. This helps to keep our lakes healthy.
- Beginning July 2024, all internal combustion engine or motor leaf blowers [including landscape company usage] will be prohibited within the city.

Since the adoption of the above ordinance along with feedback received by both residents and commercial landscapers, on April 24 of this year, the City Commission approved Ordinance #3292-24. This ordinance initiates a referendum of the voters on the possible repeal of the internal combustion engine leaf blower ban. The City Commission also delayed implementation of the ban until June 1, 2025, pending the outcome of the vote in March 2025.

Stormwater Basin Studies

The city's Public Works & Transportation and Natural Resources & Sustainability departments are leading a stormwater basin study in response to various flooding incidents experienced after intense rainfall the past few years. The study will determine the most efficient, productive and cost-effective ways to mitigate potential stormwater flooding issues throughout the city as well as create a new living stormwater model for resiliency efforts.

possible mitigation efforts could include:

- Upgrade and repair existing collection & conveyance facilities.
- New collection & conveyance systems.

Upgraded and new water quality treatment & storage facilities.

At the October 24 City Commission meeting, staff provided an update on three preliminary basin studies:

western basin study

study encompasses all drainage areas west of the chain of lakes

performed by Geosyntec Consultants, Inc.

included Lakes Bell, Killarney, Mendsen & Rose

central basin study

study encompasses all drainage areas within the chain of lakes

performed by Singhofen Halff & Associates

included Lakes Berry, Chelton, Forest, Grace, Knowles, Maitland, Mizell, Osceola, Spier, Sue, Sylvan & Virginia

eastern basin study

study will encompass all drainage areas east of the chain of lakes

performed by Baxter and Woodman, Inc.

included Winter Park Pines sub basin area

With a price tag ranging from \$27 million to \$40 million to complete all proposed mitigation recommendations, city staff will create a plan to prioritize and phase-in certain elements of each basin study recommendations in coming years. The plan will require project collaboration with adjacent municipalities as well as the St. Johns River Water Management District. In November, it was be presented to the city's Lakes & Waterways and Lake Killarney boards, and will be scheduled for presentation to the City Commission.
