Natural Resources & Sustainability Department to host Household Hazardous Waste Drop-off event

WINTER PARK, FL (January 20, 2026) The City of Winter Park's [Natural Resources & Sustainability Department](#) will host a [Household Hazardous Waste Drop-off](#) event **Saturday, March 7, from 8 a.m. to noon**, at **Cady Way Park** located at 2535 Cady Way. This **FREE** event provides Winter Park residents with the opportunity to safely dispose of hazardous household products that do not belong in regular trash or recycling bins. Accepted items include:

Household Hazardous Waste (service provided by [Waste Pro®](#)):

- fertilizers & pesticides
- gasoline
- non-alkaline batteries
- pool chemicals
- propane tanks
- tires (4 max)
- used engine oil/antifreeze
- wet latex & oil-based paint/paint thinners (4 max)

E-Waste (service provided by [Urban E Recycling](#)):

- computers
- DVD players
- fax machines
- stereos & CD players
- televisions
- VCRs

Home Textile Waste (service provided by [American Textile Recycling Service](#)):

- bed linens/pillows
- belts
- clothing
- hats
- purses
- shoes
- towels/small rugs/curtains

Important tips

- Bring **proof of residency**. [driver's license or utility bill statement]
- Keep all hazardous waste materials **in original containers with original labeling**. [unknown items will NOT be accepted]
- **Residential only, no contractors.**
- **Medication disposal:** Bring drugs and prescription medications to the **Public Safety Facility [500 N. Virginia Ave., open Monday through Friday, 8 a.m. to 5 p.m.]**

As shown in the attached map, vehicles should enter through the **Cady Way Park parking lot** and proceed to the drop-off locations while **remaining in their vehicle** throughout the drive-thru process.
